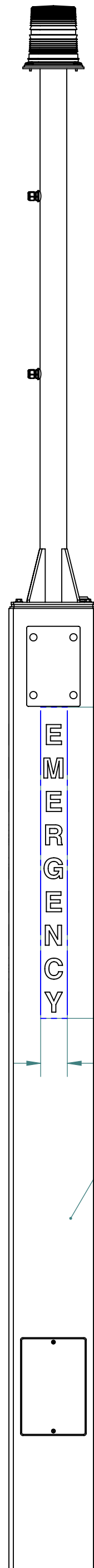

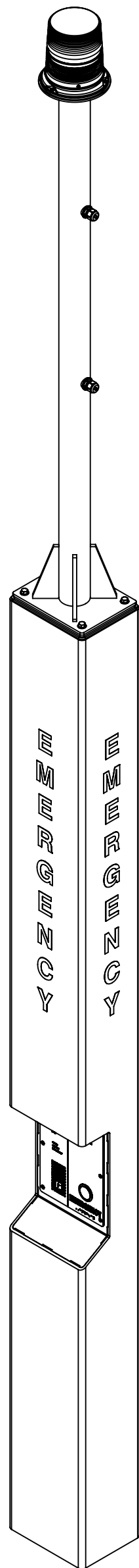


SIDE VIEW
